## About the speakers 講者簡介

### Mr Alex Lush 亞歷山大魯殊先生

Alex Lush is an assistant director of Dennis Lau and Ng Chun Man Architects and Engineers (HK) Ltd where he has been actively involved with major projects in and around the region since 1995. He is currently co-located between the practice's Hong Kong and UAE offices from where he is responsible for delivery of services in Eastern Europe, the Middle-East and locally in Hong Kong. He is closely involved in DLN's continuous process of renewal and improvement of all areas of its practice, which currently includes delivery of a number of building projects of very massive scale and complexity.



### Mr David Dumigan 鄧明庚先生

David Francis Dumigan, BSc, C Eng, FICE, FHKIE, RPE, joined Henderson Land Group in 1995 and is the General Manager of Project Management (1) Department. He is a Fellow Member of the Hong Kong Institution of Engineers and Institution of Civil Engineers. Mr Dumigan has over 28 years experience in the design and construction of major development projects in Hong Kong and Mainland China.

Mr Dumigan has been responsible for the design and construction of a number of landmark developments in Mainland China, including the two million square foot World Financial Centre (WFC), Beijing. He was also responsible for the management of the detailed design and construction of large Hong Kong projects such as International Finance Centre (IFC), Hong Kong which incorporates one of the largest basements in the world and the tallest building in Hong Kong at 420 metres.



### Mr Ma Zhencong 馬震聰先生

Mr Ma Zhencong is the Deputy President and Chief Architect of Guangzhou Design Institute (GZDI). He is also a Grade I Registered Architect, Professorial Senior Architect, Senior Professional Manager of Construction Enterprise; a Senior Member of Architectural Society of China (ASC); a member of Hong Kong Institute of Architects (HKIA); member of the 11th Council of Architectural Society of China; member of Guangdong Architecture and Environmental Art Council; Director of Guangdong Chapter of Association of Chinese Registered Architects (ACRAGD); member of Guangdong Architectural Creation Art Council Director, Guangzhou Fire Control Association (GFCA) and Mentor of Postgraduates of Master of Engineering, Guangzhou University.

GZDI is one of the largest architectural firms in southern China. The company is currently working on many commercial, recreational and public projects in Guangdong and other provinces in China.



### Mr Gary Soo 蘇國良先生

Gary Soo is the Chairman of the SMILE-NET Editorial Board and Chairman of the Construction Law Task Force of the Centre for Infrastructure & Construction Industry Development (CICID) of the University of Hong Kong. Gary is a practising Barrister and a Chartered Engineer and has been practising in areas of civil litigation involving commercial and construction disputes and arbitration. He is a listed panelist/arbitrator/mediator of various institutions in Hong Kong and Mainland China, and also of the World Trade Center Macau Arbitration Center.

In 2008, Gary took up the position to serve as the Secretary-General of the Hong Kong International Arbitration Centre, until recently in May 2010. Also, he was the President of the Hong Kong Institute of Arbitrators, from 2006 to 2008. Gary has co-authored various books, including the "Construction Law and Practice in Hong Kong". He is an Adjunct Professor of the Department of Civil Engineering, University of Hong Kong. He is now also serving as the Secretary to the Joint Mediation Helpline Office and the Chairperson of the Special Committee of Arbitration and Dispute Resolution of the Hong Kong Bar Association.
